PROCLAMATION FOR SHEILA TUCKER-GIRL SCOUT GOLD AWARD BUILDING LITTLE FREE LIBRARIES FOR LOCAL FOOD PANTRIES

Supervisor O'Connor read the proclamation of appreciation to Sheila Tucker for her building little free libraries for local food pantries. Sheila Tucker said she is honored to help children with literacy. Many of the books are in different languages to accommodate the diverse reading population. 2-1-1 PRESENTATION – DENNIS BURKE, COMMUNITY PARTNERSHIPS, UNITED WAY OF LAKE COUNTY
