### NOTICE OF PUBLIC HEARING

#### LIBERTYVILLE TOWNSHIP ROAD DISTRICT

The Highway Commissioner of Libertyville Township Road District, County of Lake and State of Illinois, hereby gives notice that upon the 21<sup>st</sup> day of October, 2025, at the hour of 7:00 p.m., at the Libertyville Township offices located at 359 Merrill Court, Libertyville, IL 60048, the Highway Commissioner will hold a public hearing at which time he will examine the route of the following Road District roads and hear reasons for or against permanently posting the following roads at the following reduced weight limits:

Prohibited for Class H registration or higher or weight of 26,000 pounds or more:
