# **Highway Commissioner's Report**

The recent storm produced about 10-12 inches of snow and required about 2 days of work. The crew did a great job. Trustee Nield asked how the salt reserve is holding up. Highway Commissioner Neal said the Road District currently has 300 tons and 300 tons will be delivered in the next few weeks. The bins have the capacity to hold the salt reserve.

The Rockland Road meeting held on March 2<sup>nd</sup> went well. Trustee Nield and Supervisor O'Connor attended. Alternative 2 with bike lanes on both the north and south sides of Rockland Road was presented. Some residents in that area have some concerns which the engineers are addressing. The comment period has been extended to March 31<sup>st</sup>.

The public meeting regarding the Phase I Casey Road Project March 7th went very well. There were approximately 70 people in attendance. Public comment has been extended to April 7<sup>th</sup>. Information for both projects has been posted on the Township website.

## Trustees' Report

Trustee Falbe said Mettawa Open Lands, which he serves on the Board, held a native seed spreading event at the property on the corner of Rt. 60 and Riverwoods Road. Eight years ago, Mettawa partnered with DePaul University to eradicate buckthorn on that property. Trustee Falbe suggested partnering Mettawa Open Lands in the future on a project to eradicate buckthorn in the area.

# Supervisor's Report

Supervisor O'Connor made some general announcements regarding the Food Pantry. The Volunteer Appreciation Tea was held on Thursday, March 9<sup>th</sup>; approximately 20 volunteers attended the event.

Supervisor O'Connor attended the opening of Fairhaven Crossing in Mundelein. It provides 40 units of affordable housing; 12 units are designated for individuals with a disability. The building's location provides access to a variety of public transportation options. The amenities include a community room, computer center, management office, playground and bike storage.
